## Representative Cases

- Although he is based in Arizona, Ryan routinely represents his clients across the United States. Ryan's clients send him anywhere, anytime to defend them. Below are some of the highlights from Ryan's career to date:
- Represented companies in the following industries/products: cargo and utility trailers, car movers, pool and spa filtration equipment, heavy earth moving equipment, consumer and commercial tires, consumer products of all types (including water filtration devices, refrigerators, and microwaves), hotel services, golf carts, chemicals, and oil and gas.
- Defends companies against the following types of claims: product liability, warranty, construction defect, premise liability, wrongful death, and general negligence.
- National product liability counsel for the largest domestic manufacturer of water filtration devices for over a decade.
- In 2014, Ryan was lead trial counsel in a product liability action, and secured a full defense verdict, in the U.S. District Court for the District of Central California (a traditionally plaintiff friendly jurisdiction). The jury took approximately 20 minutes to return the verdict.
- In 2018, Ryan was trial counsel for the nation's largest do-it-yourself moving company in Maricopa County, Arizona. Prior to trial the judge issued a summary judgment ruling that his client's product violated one of Arizona's statutes and instructed the jury on negligence per se. Despite the horrific odds in light of that pending jury instruction, the jury returned a full defense verdict in favor of Ryan's client following the 4-week trial. The verdict was identified as the second most significant defense verdict in the State of Arizona in 2018 ([As highlighted by Arizona Attorney Magazine here](#)). Additionally, Courtroom View Network identified the verdict as the second most impressive product liability defense verdict in the country in 2018.
